1. **FUNDING SOURCES:** the EEA Grants –Financial Mechanism (EEA) 2014-2021 and the Romanian Government
2. **DONOR STATES:** Iceland, Liechtenstein, Norway
3. **BENEFICIARY STATE:** Romania
4. **PROGRAMME OPERATOR:** National Agency for Community Programmes in the Field of Education and Vocational Training (Agentia Nationala pentru Programe Comunitare in Domeniul Educatiei si Formarii Profesionale, ANPCDEFP)
5. **DONOR PROGRAMME PARTNERS:** **The Norwegian Agency for International Cooperation and Quality Enhancement in Higher Education - DIKU** and The National Agency for International Education Affairs – **AIBA**.
6. **SCOPE OF THE PROGRAMME:** Contributing to the reduction of economic and social disparities in the European Economic Area and strengthening the bilateral relations between the EEA states and Romania.
7. **GENERAL OBJECTIVE:** Enhancing the human capital and knowledge base in Romania

**PARTICULAR FEATURES OF THE CALL FOR PROPOSALS FOR COOPERATION PROJECTS IN THE HIGHER EDUCATION AREA**

**1. BUDGET ALLOCATED TO THE CALL: 570 508 EUR**

The minimum allocated grant per project is 20 000 Euro and the maximum allocated grant is 200000 Euro.

**2. TYPES OF PROJECTS TO BE FUNDED:**

- **Strategic cooperation projects**
- **Small size cooperation projects**

The main objectives of the Cooperation Projects in The Higher Education Area are to modernise/innovate the curricula, to exchange good practices in the field of teaching methodologies and to organise short term exchanges for students and teachers.

**NB: Projects that address: a) the topics of Social inclusion of vulnerable groups (with a focus on Roma), b) Democracy and Citizenship or c) that ensure synergies with approved projects within programmes: Research, Business Development, Innovation and SMEs, Renewable Energy, Energy Efficiency or Energy Security will be encouraged through additional priority points (maximum 10 points awarded for each priority a, b or c). The priority points won't be awarded unless the minimum score was achieved by the project. For more details, see [2019 Guide for applicants](#).**

**3. PROJECT RESULTS**

The projects submitted under this Call for Proposals should contribute to the achievement of outcome no. 2.1 and output no. 2 as follows:

#### 4. WHO COULD APPLY

For Strategic cooperation projects and small size cooperation projects, applicants must be accredited higher education institutions (universities) from Romania which hold an Erasmus Charter for Higher Education (ECHE).

#### 5. CO-FUNDING

For Cooperation projects in the Higher Education area the grant will cover 100% of the eligible costs.

#### 6. APPLICATION DOCUMENTS:

##### 6.1 Annexes of the applications for Cooperation projects in The Higher Education Area:

- a) Table of detailed requested budget;
- b) Timeline of activities;
- c) Declaration of honour of the legal representative of the applicant institution (this document will be printed, signed and then scanned and uploaded);
- d) In the case of a VET partner from Switzerland, the copy of the cooperation agreement with Liechtenstein.
- e) Communication Plan

If the applicant is a non-public institution, the documents mentioned in 6.2, 6.3 and 6.4 must also be attached to the application form, besides the documents mentioned in 6.1.

**6.2 Only for Romanian non-public institutions:** copy of the registration in the Register of Commerce and the Ministry of Public Finances;

**6.3 Only for Romanian non-public institutions:** the fiscal certificate, proving the lack of unpaid debts to the State budget;

**6.4 Only for Romanian non-public institutions and if the requested grant is higher than 60.000 Euro:** copy of the most recent yearly financial statement submitted to the Ministry of Public Finances

## **7. HOW TO APPLY?**

The completed application, in English, has to be sent online using the submission tool available at [www.eea4edu.ro](http://www.eea4edu.ro). The compulsory annexes will be uploaded.

## **8. DEADLINE**

The applications for Cooperation Projects in The Higher Education Area have to be sent no later than 30.01.2020, 13.00 hours (Romanian time).

Any application sent after the above-mentioned date will be declared ineligible.

## **9. CONFIRMATION OF RECEIPT**

After the online submission of application, the applicant will receive an automatic submission confirmation.

## **10. PUBLICATION OF THE SELECTION RESULTS**

Results will be published on the website [www.eea4edu.ro](http://www.eea4edu.ro), until 01.04.2020.

## **11. NB: CONCERNING DOUBLE FUNDING**

According to the principles of correct and sound financial management, double funding is strictly forbidden.

Thus costs for the same activity cannot be covered from two different funding sources, with the exception of cases where complementarity can be clearly proven.

Funding for one and the same project cannot be granted more than once.

Also, if identical applications (in content) will be identified or if applications will contain paragraphs similar or identical to other applications (no matter if submitted under the same deadline or not and no matter if submitted by the same candidate or different candidates, for the EEA Grants – Financial Mechanism 2014-2021 or for another programme managed by ANPCDEF), these applications will be REJECTED.

In the case where double funding is discovered after the respective applications have already been approved and funded, the grant beneficiaries will have to return to ANPCDEF all the amounts already received for the implementation of the project.

## **12. OTHER ADMINISTRATIVE REGULATIONS**

The Programme Operator reserves the right to carry out a financial analysis and institutional capacity check for Project Promoters who are NOT public institutions which either have a project approved with a grant of more than 60,000 Euro or, although not exceeding a grant of 60,000 Euro / project, exceeds EUR 100,000 / year, cumulated from several projects; if this internal risk analysis leads to the conclusion that places this promoter in a risk category, the PO may take the decision to award the contract under special conditions.

Contracts for the projects received from the candidates with whom the ANPCDEFP is in dispute for debts recovery and which have a score to be financed will be issued only under a special condition: with 0(zero) advance/pre-financing and the return of all eligible costs after the approval of the final report.
