**PARTICULAR FEATURES OF THE CALL FOR PROPOSALS FOR MOBILITY PROJECTS IN HIGHER EDUCATION:**

### **1. BUDGET ALLOCATED TO THE CALL: 1 000 000 Euro**

The minimum allocated grant per project is 1500 Euro and the maximum allocated grant is 500 000 Euro.

### **2. TYPES OF PROJECTS TO BE FUNDED:**

#### **MOBILITY PROJECTS IN HIGHER EDUCATION**

The main objective of the Mobility projects in higher education is **to improve the skills and competences of students and staff in Higher Education, through enhancing students and staff mobility between Romania and DS.**

#### **Synergy**

RO HEI's can include in the application form also master students that are involved in research projects submitted through EEA Grants - Collaborative Research Projects. Those mobilities will be financed only if the respective project is approved by the relevant Programme Operator.

#### **Priorities**

In the selection process, the HEIs will give priority (through bonus points) for Roma students and staff, for people with special needs, for socio-economic disadvantaged students and master students involved in approved research projects and financed through EEA Grants 2014-2021.

### **3. PROJECT RESULTS**

The projects submitted under this Call for Proposals should contribute to the achievement of the following direct results (outputs) and indirect results (outcomes):

#### 4. WHO CAN APPLY

For Mobility Projects, applicants must be accredited higher education institutions (universities) from Romania which hold an Erasmus Charter for Higher Education (ECHE). Individuals can apply for grants only via an eligible institution.

#### 5.CO-FUNDING

For Mobility projects in Higher Education the grant will cover 100% of the eligible costs.

#### 6.APPLICATION DOCUMENTS:

##### Annexes of mobility projects applications:

- a) copies of the inter-institutional agreements (bilateral agreements) concluded with the partner HEIs for the exchanges (for study mobility of students and teaching mobility for staff);
- b) table with the detailed requested budget;
- c) declaration of honour of the legal representative of the applicant institution (this document will be printed, signed and scanned).

d) communication plan

If the applicant is a non-public institution, the documents mentioned at 6.2, 6.3 and 6.4 must be also attached to the application form, besides the documents mentioned at 6.1.

**6.2 Only for Romanian non-public institutions:** copy of the registration in the Register of Commerce and the Ministry of Public Finances;

**6.3 Only for Romanian non-public institutions:** the fiscal certificate, proving the lack of unpaid debts to the State budget;

**6.4 Only for Romanian non-public institutions and if the requested grant is higher than 60.000 Euro:** copy of the most recent yearly financial statement submitted to the Ministry of Public Finances

## **7. HOW TO APPLY?**

**The completed application, in English, has to be sent online using the submission tool available at [www.eea4edu.ro](http://www.eea4edu.ro). The compulsory annexes will be uploaded.**

## **8. DEADLINE: 25.10.2021 at 13.00 hours (Romanian time)**

**Any application sent after the above-mentioned date will be declared ineligible.**

## **9.CONFIRMATION OF RECEIPT:**

After the online submission of application, the applicant will receive an automatic confirmation.

## **10. PUBLICATION OF SELECTION RESULTS:**

Results will be published on the website [www.eea4edu.ro](http://www.eea4edu.ro), no later than 15.12.2021.

## **11. CONCERNING DOUBLE FUNDING:**

According to the principles of correct and sound financial management, double funding is strictly forbidden.

Thus costs for the same activity cannot be covered from two different funding sources, with the exception of the case where complementarity can be clearly proven.

Funding for the one and the same project cannot be granted more than once.

Also, if identical applications (in content) will be identified or if applications will contain paragraphs similar or identical to other applications (no matter if submitted under the same deadline or not and no matter if submitted by the same candidate or different candidates, for the EEA grant programme or for another programme managed by ANPCDEFP), these applications will be REJECTED.

In the case where double funding is discovered after the respective applications have already been approved and funded, the grant beneficiaries will have to give back to ANPCDEFPP all the amounts already received for the implementation of the project.

## **12. OTHER ADMINISTRATIVE REGULATIONS**

The Programme Operator reserves the right to carry out an financial analysis and institutional capacity check for Project Promoters who are NOT public institutions and - either have approved a project with a grant of more than 60,000 Euro or not exceeding a grant of 60,000 Euro / project, exceeds EUR 100,000 / year, cumulated from several projects, when the internal risk analysis, based on the management of previous projects, leads to this conclusion and therefore take the decision to award the contract under special conditions .

Contracting of the projects received from the candidates with whom the ANPCDEFPP is in dispute for debts recovery and which have a score to be financed will be made only under special conditions: with 0(zero) advance and the return of eligible costs after approval of the final report.
